Quarterly STEC Verification

Dear Customer:

This Letter is to convey the results of the STX Beef Company, LLC. Quarterly E. coli O157:H7 and Non-O157 STEC's (O26, O45, O103, O111, O121, O145) "Verification" testing. As part of our ongoing validation of our Food Safety System, as well as following the industry guidelines on "Best Practices" as delineated in FSIS Notice 65-07, and ongoing customer requests for non-O157 STEC verification testing, we will perform verification testing of trimmings as a raw ground beef component as least quarterly.

Each quarter, STX Beef Company, LLC will take a "lot" of trimmings that have already been tested and found negative for E. coli O157:H7 and non-O157 STECs using a statistically valid sampling plan and ground the product. This ground product will then be sampled using a statistically valid sampling plan and following USDA/FSIS guidelines for sample size, analysis, and detection limits. This ground sample release will be used as our "Verification."
